NATURAL RESOURCES & MINING and PRO. & BUSINESS SERVICES

March brought Oklahoma strong year-over-year growth in NATURAL RESOURCES & MINING and PROFESSIONAL & BUSINESS SERVICES. Over the year, these two industries added 1,700 jobs

(+5.6%) and 8,000 jobs (+5.1%), respectively.

MANUFACTURING

Compared to March 2004, MANUAFACTURING has dropped by 600 jobs (-0.4%). The NON-DURABLE GOODS sector was responsible for the year-over-year loss, as it shed 1,100 jobs for the year. The DURABLE GOODS MANUFACTURING sector actually grew by 500 jobs (+0.5%) compared to March 2004.

NUMBER of UNEMPLOYED

□ more than 12% over year

The number of UNEMPLOYED Oklahomans dropped by 11,466 (-12.7%) between March 2004 and March 2005. A corresponding gain in EMPLOYMENT over the same period suggests that many of these formerly UNEMPLOYED persons re-entered the workforce.

IN A NUTSHELL . . .

"Oklahoma's non-farm employment continued to pick up steam in March. While not quite on pace with February's strong annual growth rate, state employment is growing at a clip of 1.7 percent, much stronger than at any time in 2004. Oklahoma City virtually matched the state growth rate in March, while Tulsa saw small losses for the month. Although not directly measured, the indication is that the non-metro portions of the state are currently experiencing the strongest employment growth." - Lynn Gray, OESC Managing Economist

NOTE: This publication is produced by the Economic Research & Analysis division of the Oklahoma Employment Security Commission as a no cost service for the state of Oklahoma. All information contained within this document is available free of charge on the OESC website (www.oesc.state.ok.us/lmi/) and through LMI publications developed by the ER&A division. <u>Unless</u> otherwise noted, all statistics are preliminary and have not been adjusted for seasonal factors. All data is collected under strict guidelines provided by the Bureau of Labor Statistics. Although a large amount of data has been presented through the included tables, this is in no way meant to suggest that all data has been included. Due to space restrictions, only relevant industries and subsectors have been included for each geographic area.

STATE UNEMPLOYMENT RATE CONTINUES TO IMPROVE IN MARCH

In March 2005, the **State Unemployment Rate** dropped by two-tenths of a percent to 4.6 percent for the month. Since the 5.2 percent rate reported in January, Oklahoma's **Unemployment Rate** has decreased each month of 2005.

Oklahoma's **Non-seasonally Adjusted Employment** and **Non-seasonally Adjusted Labor Force** both held relatively steady from February to March, reporting gains of only 5,150 persons (+0.3 percent) and 1,430 persons (+0.1 percent), respectively. With two of the three factors controlling the unemployment rate at a relative stand still, the state's **Non-seasonally Adjusted Unemployment**, which dropped by 3,730 people (-4.8 percent) in March, is mostly responsible for the fluctuation in the unemployment rate.

One important point is that this does not mean that the 3,730 people who left the ranks of the unemployed all found jobs or are now counted as part of the **Employed** or **Labor Force** numbers. To be classified as unemployed for purposes of calculating the unemployment rate, one must not have a job and be actively seeking work. Those who do not actively seek work are known as "discouraged workers." People falling into this group are NOT counted as part of the employed, unemployed or labor force, and, as such, do not have any effect on the unemployment rate. Once a discouraged worker begins actively seeking work, that individual is once again part of the calculation.

In closing, it should be noted that Oklahoma's unemployment rate is at least four-tenths of the percent below any other state in our geographic region.

TULSA & LAWTON SEE RATE DROPS, OKC HOLDS STEADY IN MARCH

Following the trend of the state, two of the three Oklahoma MSAs managed improvements in their unemployment rates for March. The **Oklahoma City MSA** was the odd man out as its unemployment rate held steady at 4.5 percent over the month. **Tulsa MSA** improved by three-tenths of a percent to 4.4 percent, as **Lawton MSA** also lost three-tenths to reach 4.3 percent for March.

COUNTIES WITH HIGHEST RATES SEE IMPROVEMENT OVER MONTH

Coal County once again claimed the state's highest unemployment rate in March, despite seeing its rate drop from 9.6 percent to 8.4 percent over the month. **Seminole County** held the second lowest rate at 8.3 percent, an improvement of half a percent. **Okfuskee County** was third for the month at 8.2 percent, also an improvement over the previous month.



At 2.4 percent for the month, **Roger Mills County** held the state's lowest county unemployment rate in March. **Ellis County** came in second at 2.5 percent, and **Beckham County** rounded out the three lowest rates for the month at 2.7 percent.

STATE EMPLOYMENT LOGS STRONG GROWTH FOR MONTH, YEAR

Oklahoma's TOTAL NONFARM EMPLOYMENT added 11,000 jobs (+0.7 percent) in March, bringing the state's over-the-year gain to 24,400 jobs (+1.7 percent). For the Goods Producing Industries, Natural Resources and Mining was the big mover in March, growing by 1,700 jobs (+5.6 percent) over the year. The Service Providing Industries contributed most of the monthly and annual changes. Trade, Transportation and Utilities and Professional and Business Services provided over half of the state's monthly gain, while Professional and Business Services and Government added more than 17,000 jobs over the year.

NATURAL RESOURCES & MINING SEES BIG CHANGE OVER YEAR

Natural Resources and Mining across the state added 200 jobs (+0.6 percent) over the month, pushing its over-the-year gain to 1,700 jobs (+5.6 percent). The **Support Activities for Mining** sector provided around half of both the monthly and annual gains.

STATEWIDE CONSTRUCTION ADDS JOBS OVER MONTH IN MARCH

Construction gained 700 jobs (+1.2 percent) over the month, but fell 300 jobs short (-0.5 percent) of its March 2004 employment level. The **Heavy and Civil Engineering** and **Specialty Trade Contractors** sectors provided the over-the-month growth. **Specialty Trade Contractors** also provided the only annual growth seen in this industry for March. The **Construction** industry in Tulsa provided 500 of the 700 jobs gained for the month.

OKLAHOMA MANUFACTURING DIPS IN MARCH 2005

Statewide **Manufacturing** dropped 400 jobs (-0.3 percent) in March, as the **Durable Goods** and **Non-durable Goods** sectors both lost jobs over the month. Since March 2004, **Durable Goods Manufacturing** in Oklahoma has added 500 jobs (+0.5 percent), while statewide **Non-durable Goods Manufacturing** has shed 1,100 jobs (-2.3 percent). Despite the slow month elsewhere, **Manufacturing** in Oklahoma City posted small job gains for both the month and year.

RETAIL TRADE BOUNCES BACK AFTER HOLIDAY SEASON

Trade, Transportation and Utilities added 3,200 jobs (+1.2 percent) in March, as the **Retail Trade** sector rebounded from seasonal losses following the holiday shopping season. The **Wholesale Trade** and **Transportation, Warehouse and Utilities** sectors both contributed over the month and year, but it was **Retail Trade** that spurred the over-the-month growth with an addition of 2,300 jobs (+1.4 percent) in March.

PROFESSIONAL & BUSINESS SERVICES REFLECTS HEALTHY GROWTH FOR MONTH AND YEAR IN MARCH

Professional and Business Services reported healthy gains for both the month and year in March 2005. The **Administrative and Support Services** sector, driven again by **Employment Services**, managed gains of 2,200 jobs (+2.4 percent) over the month and 6,500 jobs (+7.5 percent) over the year. **Professional and Scientific Services** also reported a big gain for the year, adding 1,300 jobs (+2.3 percent) between March 2004 and March 2005. Tulsa was the only MSA not contributing to the annual gain in this industry.

EDUCATIONAL & HEALTH SERVICES ADDS JOBS OVER YEAR

Despite recording only slight gains for the month, **Educational and Health Services** added 3,000 jobs (+1.7 percent) over the year. The **Health Care and Social Assistance** sector provided a majority of the industry's annual growth in March, expanding by 2,400 jobs (+1.5 percent) due to hiring in **Ambulatory Health Care** and **Hospitals** over the past year. The three MSAs combined to provide only one-sixth of the annual growth in this industry, leaving the rest to non-MSA areas across the state.

LEISURE & HOSPITALITY INDUSTRY GROWS FOR MONTH & YEAR

Leisure and Hospitality gained 1,200 jobs (+0.9 percent) in March 2005, putting the industry up by almost the same amount over the year. The **Accommodation and Food Services** sector was the source of two-thirds of the monthly gain and almost all of the annual addition. A majority of this growth resulted from changes in the **Food Services and Drinking Places** subsector. Tulsa was the only MSA not gaining jobs in this industry over the year.

GOVERNMENT EXPERIENCES LARGE GAIN FOR YEAR

With a 400-job addition (+0.1 percent) over the month, **Government** across the state increased its annual growth to 9,400 jobs (+3.1 percent). The monthly gain was shared between **State Government** and **Local Government**. **Local Government** contributed 7,600 jobs (+4.3 percent) to the industry's annual gain. All MSAs reported over-the-year growth in March.

OKLAHOMA CITY ONLY MSA TO GAIN JOBS FOR BOTH MONTH, YEAR

In March, Oklahoma City **TOTAL NONFARM EMPLOYMENT** added 4,600 jobs (+0.8 percent) over the month and 8,700 jobs (+1.6 percent) over the year. The **Service Providing Industries** contributed most of the monthly growth and more than three-quarters of the jobs gained for the year. The combination of **Trade**, **Transportation and Utilities** and **Professional and Business Services** provided over-the-month gains, as **Government** helped push the MSA to annual growth.

Following a few months of ups-and-downs due to temporary work stoppages, Oklahoma City **Manufacturing** enjoyed a relatively inactive month, gaining 100 jobs (+0.3 percent) since February and 400 jobs (+1.0 percent) since March 2004. **Durable Goods Manufacturing** accounted for a quarter of the annual growth. For March, the Oklahoma City MSA was the only area reporting either over-the-month or over-the-year growth in **Manufacturing**.

RETAIL TRADE PROVIDES CHANGES FOR TTU INDUSTRY IN OKC

In March, **Retail Trade** once again garnered the attention, as it provided a majority of the monthly gain and all of the annual loss in Oklahoma City's **Trade, Transportation and Utilities** industry. **Retail Trade's** annual loss of 1,000 jobs (-1.7 percent) was the only negative change reported by the industry's three main sectors in March. Over the month, **Trade, Transportation and Utilities** managed to add 1,000 jobs (+1.1 percent) and gain back ground lost to seasonal drops over the past few months.

ADMINISTRATIVE & SUPPORT SERVICES SECTOR HELPS INDUSTRY TO GAINS FOR MONTH AND YEAR

March was a good month for **Professional and Business Services** in Oklahoma City, as the industry added 1,000 jobs (+1.5 percent) over the month and 1,600 jobs (+2.5 percent) over the year. It was the **Administrative and Support Services** sector that provided a majority of both gains. The **Employment Services** and **Business Support Services** subsectors contributed double-digit growth (+10.0 percent and +22.7 percent, respectively) to the industry's large over-the-year gain (+1,600 jobs).
