Many county unemployment rates continue to edge upward in February

Oklahoma's non-seasonally adjusted unemployment rate rose to 5.9 percent in February 2009. **Hughes County** recorded the highest county unemployment rate, and **Beaver and Harper counties** shared the lowest county rate. Sixty of the state's 77 counties posted rate increases for the month. Of the counties that reported rate drops for the month, three (**LeFlore**, **Sequoyah** and **Tillman**) saw decreases of more than 2.0 percentage points for February.

State unemployment continues to expand in February

Oklahoma's statewide **non-seasonally adjusted labor force** and **employment** both contracted in February, while **non-seasonally adjusted unemployment** grew by 5.8 percent. Compared to February 2008, statewide **non-seasonally adjusted unemployment** increased by 73.9 percent, or 44,030 persons.


