
UNEMPLOYMENT FOR STATE, MSAs DROPS IN FEBRUARY

- The state unemployment rate dropped very slightly over the month, losing one-tenth of a percentage point to 5.5 percent from January's revised rate of 5.6 percent. This rate is down the same amount when compared to February 2003.
- For February 2004, the **Oklahoma City MSA** unemployment rate was unchanged at 4.7 percent. **Tulsa MSA** dropped to 6.4 percent from January's revised rate of 6.6 percent. The **Lawton** and **Enid MSAs** also dropped to 3.5 percent and 3.4 percent, respectively.
- At 1.4 percent unemployment, **Roger Mills County** recorded the lowest unemployment rate among Oklahoma's 77 counties for the second time in 2004. **Ellis County** (2.0 percent) and **Texas County** (2.1 percent) rounded out the top three lowest rates for the month.
- Coal County's unemployment rate of 21.7 percent was again the state's highest rate. It has held this position since February 2003. Adair County's 12.4 percent and Woods County's 11.7 percent rounded out the top three highest unemployment rates in February 2004.

LABOR FORCE AND EMPLOYMENT GAIN OVER MONTH

- Oklahoma's **Non-seasonally Adjusted Labor Force** gained 12,200 persons (+0.7 percent) to reach 1,688,400 people in February 2004. Since last February, the **Labor Force** has added 6,700 persons (+0.4 percent).
- Oklahoma's **Non-seasonally Adjusted Total Employment** also experienced a significant over-the month gain, adding 12,700 people (+0.8 percent) to finish at 1,595,900 in February. It was one of the largest gains the state has seen for the January-February period in recent years. Compared to February 2003, **Total Employment** is up by about the same amount, adding 11,700 jobs (+0.7 percent) to last February's total.
- At 92,500 people, Oklahoma's **Non-seasonally Adjusted Unemployment Number** was little changed from January's revised number, dropping 500 people (-0.6 percent). For the twelve months ending in February 2004, the number of unemployed decreased by more than 5,000 people (-5.2 percent) from the 97,600 reported in February 2003.

TOTAL NONFARM EMPLOYMENT in Oklahoma gained 8,800 jobs in February 2004, bringing employment up to 1,433,000 jobs. Most of the **Service Providing Industries** reported over-the-month gains totaling 10,300 jobs, more than offsetting the 1,500-job loss experienced by the **Goods Producing Industries** in February.

NON-RESIDENTIAL CONSTRUCTION SLOWDOWN LEADS TO LOSSES Goods Producing Industries

Construction once again experienced job loss in February 2004, dropping 1,400 jobs (-2.4 percent). Since February 2003, **Construction** has lost 3,600 jobs due mostly to a slowdown in **Construction of Buildings**, more specifically the **Non-residential Building** subsector which has shed over 15 percent of its workforce since last year.

TRADE, TRANSPORTATION AND UTILITIES CONTINUES SHEDDING JOBS Service Providing Industries

Trade, Transportation and Utilities continued its decline, dropping 3,300 jobs in February 2004. Although **Wholesale Trade** held steady for the month, **Retail Trade** managed to shed 3,500 jobs (-2.1 percent) with General Merchandise Stores accounting for 1,400 of the jobs lost. Since February 2003, **Trade, Transportation and Utilities** has dropped 5,600 jobs (-2.0 percent).

In February 2004, **TOTAL NONFARM EMPLOYMENT** in the Oklahoma City Metropolitan Statistical Area (MSA) added 6,100 jobs (+1.2 percent) to reach 530,100 jobs for the month. Compared to February 2003, employment in the MSA has declined by 400 jobs (-0.1 percent). Employment in the **Goods Producing Industries** dropped 800 jobs (-1.2 percent) over the month, while the **Service Providing Industries** saw an increase of 6,900 jobs (+1.5 percent).
